Additionally, he co-counselled on landmark immigration cases, where he drafted detailed submissions for judicial review, asylum claims, and deportation challenges, focusing on international human rights law. In the criminal sector, Yousif played a central role in trial preparation, evidence review, courtroom strategy, and direct court appearances, further honing his drafting abilities for legal memoranda, case theories, and courtroom submissions.
